Feedback comments – what we could improve on

Some parts of the presentation were informative, but most of it used a lot of jargon and was hard to understand.

Although webinars ok in general, and it was well presented, when discussing issues regarding pensions I would prefer one to one advice.

It was a little bit of a hard sell on AVC and I don't think the downside was presented very well, but was an informative presentation about the product on offer.

I took a lot from the presentation but for me it was a lot of information to take in in 1 hour. It would have been useful to have been given the slides prior to the presentation so you could have a read and formulate questions.

It was basically very complicated and hard to understand for someone who does not already know a lot about pensions

I appreciate that there was a lot to get through but the delivery was very fast and didn't always allow time to digest some of the facts/information/examples.

Lots of really good information, but delivered too fast to fully understand.
